**Becker 147.345 + FM DCS 172 DN . . .**

Dave KGØCV reported that the site owner Excell Energy, was still doing the

Covid 19 lock down. Unfortunately, the DARC is a non essential personnel so we're the very last to be allowed on the site. It looks like maybe we can go there in the spring ? ? Dave has the brand new antenna for the Becker 147.345 + repeater in his shop ready to go. Tom KDØMOM suggested we E-mail Todd Krause & Jim Richardson at the National Weather Service In Chanhassan to see if they can E-mail back that we need our Becker Skywarn Hub back up & running. Dave will E-mail the National Weather Service in Chanhassan.

#### Becker 443.475 + FM DCS 172 DN . . .

Rick NØBJN stated this repeater continues to be Linked to the DARC Room on Yaesu Fusion Digital to the DARC Room 28439. It's been running good.

#### Paynesville 145.270 - FM DCS 172 . . .

Shannon NØANC told the group that this repeater is not running very good. It won't duplex on it's antenna. It gets noise from somewhere & acts up. It's using a separate receive & transmit antennas. It has a big mouth & poor ears on the separate antennas to keep the noise out. Shannon suggested we take the new Becker 2 meter antenna & put it up at Paynesville 145.270 - site since we can't go to the Becker site. Dave KGØCV said this is the best way to go. Dave added we could get a Hustler mono bander antenna for the Becker site that would go right up the elevator at Becker. After further discussion, **Motion 2021-021** was made by Shannon NØANC to send the new Becker 2 meter antenna to Paynesville 145.270 - FM repeater site. It was seconded by Rick NØBJN. 10 Yes Votes. 0 No Votes. Motion passed.

#### Paynesville 224.800 - FM . . .

Dave KGØCV reported this repeater is still running barefoot without the amplifier. He stated with the amplifier, it gets a lot of desense. He wants some help from Nick KDØILR to fine tune the duplexer further than what Dave can do.

#### Paynesville 444.625 + DN . . .

Rick NØBJN said this repeater continues to function good Linked to the DARC Room 28439. The Link is provided by Dean NYØI in Paynesville.

#### St Cloud 145.190 - DN . . .

Shannon NØANC stated this repeater is Linked to MNWIS ( an abbreviation for MN Wisconsin ) Room 21493 most of the time. It can be Linked to any Room a Ham Operator wishes.

**St Cloud 442.150 + FM DCS 172 or DN . . .**

Shannon NØANC said this repeater can be Linked to any Room a Ham Operator wants.

**St Cloud 443.850 + DCS 172 or DN . . .**

Shannon NØANC reported the DR2X Yaesu Fusion Digital repeater has gone belly up. He said the screen won't come on & it won't transmit or repeat. He replaced it with his extra DR2X repeater. He would like to send the belly up repeater back to Yaesu to see if it can be repaired. **Motion 2021-22** was made by Shawne KFØAUW to send the Yaesu DR2X repeater to Yaesu for repair & reimburse Shannon shipping costs. It was seconded by Rick NØBJN. 10 Yes Votes. Ø No Votes. Motion passed.
